CT scanning, sometimes called CAT scanning, is a noninvasive medical test that helps physicians diagnose and tailor treatments for various medical conditions.

The ACR gold seal of accreditation represents the highest level of image quality and patient safety. It is awarded only to facilities meeting ACR Practice Guidelines and Technical Standards after a peer review evaluation by board certified physicians and medical physicists who are experts in the field. Image quality, personnel qualifications, adequacy of facility equipment, quality control procedures and quality assurance programs are assessed. The findings are reported to the ACR Committee on Accreditation, which subsequently provides the practice with a comprehensive report they can use for continuous practice improvement.

The mission of Gilbert hospital is to provide the highest quality of health care services to the communities they serve.

"The accreditation reassures the community that we believe in and deliver healthcare as promised in our mission statement," says Sheelagh Lindberg, diagnostic radiology director.

Additionally, replacement costs for old T12 fluorescent lamps and ballasts may increase because of reduced supply. New federal standards required phasing out production of these lamps and ballasts. SRP business customers are encouraged to upgrade T12s now while rebates are at their highest levels.

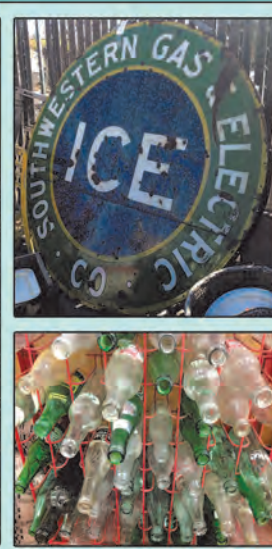
